The D7 Visa, also known as Portugal Retirement Visa or Passive Income Visa. This residence visa allows any non-EU/EEA/Swiss citizen with reasonable net regular passive income to apply for residency in Portugal.

OVERVIEW

Portugal is one of the most desirable destinations in Europe for Tourists and Investors. The government of Portugal initiated D7 visa category in 2007 with an intention to facilitate maximum people. This is also known as Portugal retirement visa or a Passive Income visa. This residence visa allows any non-EU/EEA/Swiss citizen who has a reasonable net regular passive income to apply for residency in Portugal. This income can be from pensions, transferable equity, real estate, intellectual property, or financial investment. D7 Visa allows legal status of residency to the applicants with spouse and children. This specific scheme has been designed for retirees, people with a passive income or those who want to relocate to Portugal with family with a sustainable plan. Applicants are not restricted to work or do business under this visa category. It is a very easy and credible pathway to get residency in Europe which is definitely leading to citizenship in longer run.

ELIGIBILITY CRITERIA

- Applicant must be above 18 years of age and a Non-EU National.
- Must have a yearly income around EUR 8500.
- Applicant needs to show a residence address in Portugal.
- Must maintain a clear criminal history.
- Need to spend minimum 16 months in Portugal during initial 2 years.



HOW PORTUGAL D7 VISA WORKS?

Portugal D7 does not require any specific investment amount but a stable passive source of income. The D7 Visa requires a demonstration of stable passive income. This income can stem from pensions, real estate, investments, dividends, or royalties. The minimum passive income expected is €8,460 per year for a single applicant. Add an additional 50% of this baseline amount for spouse, and for each dependent child, an extra 30%. Applicants will get two years permit initially which can be extended and leads to citizenship. It is must to maintain a health insurance and physical presence in the country.

SINGLE APPLICANT

€8,460/Per Anum.

APPLICANT WITH SPOUSE

€8,460 + €4,230/Per Anum.

FOR EACH DEPENDENT CHILD

Additional €2,538/Per Anum.



FAMILY REUNIFICATION

ELIGIBLE FAMILY MEMBERS:

The spouse or de facto partner.

Minor or incapacitated children (natural or adopted) financially dependent on the main applicant, couple or spouse/partner.

Single children (natural or adopted) over the age of 18, financially dependent on the main applicant, couple or spouse/partner, and enrolled in a higher education programme or school in Portugal.

Parents and in-laws over 65 years of age, or under 65 if financially dependent on the main applicant, or couple spouse/partner.

Underaged siblings if under guardianship granted by the competent authority of the country of origin, provided that this decision is legally accepted in Portugal.

Notes: Adopted children by the main applicant, spouse/partner or couple are eligible, provided that the law of that country grants adopted children the same rights and duties of a natural child and that the decision is legally accepted in Portugal.

Family reunification for a minor or incapacitated child of one of the spouses is dependent on the permission of the other parent or on the decision of a competent authority of the country of origin, provided that this decision is legally accepted in Portugal.

THE RESIDENCE CARD

The residence card is valid for 2 years. At the end of these 2 years, you can renew it for an additional period of 3 years. At the end of 5 years you can apply for a permanent residence permit or for Portuguese citizenship.

In order to renew the residence card, you should not leave the country for more than 6 consecutive months, or 8 months non-consecutive, during the period of each card.

Note: longer absences related to work, assistance to family, health issues, among other reasons, may not prevent the renewal of the residence card, but must be duly informed and proven to AIMA.

At the time of the application for a permanent residence permit or for Portuguese citizenship, you must prove that you have a basic knowledge of the Portuguese language (level A2)



SERVICES IN OUR PROPOSAL

- Obtaining a tax identification number (NIF).
- Tax representation for a period of 1 year. After 1 year, a yearly fee of € 200 will be charged per person.
- Personal bank account setup.
- Information on the procedure and documents required to obtain the visa and residence permit.

- Appeal to the Consulate in the case of visa rejection (judicial appeals are not included).
- Scheduling appointments at AIMA.
- Preparation of the appointment with AIMA to obtain the Residence Permit.

The bank account will be considered set up when the Bank confirms it is active. From that moment on, any communications related to obtaining cards, access details, etc, should be directed to the bank account manager. If our intervention is required at that stage, it will have an additional cost.

07 FAMILY REUNIFICATION (OPTIONAL)

If you wish to apply for Family Reunification, an appointment will be set up with AIMA to this end.



08 RESIDENCE VISA

The visa is issued with an appointment with AIMA 2-3 months after the application.



09 RELOCATE TO PORTUGAL

Travel to Portugal to convert the visa into a Residence Permit.



10 COLLECTION OF DOCUMENTS

Preparation of the documents required for the AIMA appointment.



11 APPOINTMENT WITH AIMA

A lawyer will escort you to the appointment.



12 RESIDENCE CARD

The card will be sent to your Portuguese address within 1-3 months.

The timeline depends solely on the Consulates and AIMA and is associated with the specifics of each family's situation.
