INVESTMENT IN A PORTUGUESE VENTURE

The applicant can make an investment of EUR 500,000 in a new venture or a qualifying capital venture and get permanent residency. This investment must have a minimum maturity period of five years, and at least 60% of the investment value should be directed toward commercial companies based in Portugal.

JOB CREATION OPTION

Creation of a minimum of 10 new full-time jobs in a Portuguese business, the ownership must be in name of main applicant or invest a minimum €500,000 in an existing Portuguese company, where the incorporated business must create a minimum of five new full-time jobs for three to five years.

Note: Real Estate Investment Option and Capital Transfer Route is no more applicable to acquire Portugal Golden Visa.
