# UNITED KINGDOM

## Self Sponsorship Program

- ▶ Allows a migrant to get a visa and migrate in a fast track process.
- ▶ No requirements to show performance by the UK company prior to arrival and during visa period.
- ▶ Visa can be issued for 5- years from the start & leads to PR for main applicant, wife and children Under 18 after 5 years.
- ▶ PR requirements: 185 days residence, 5 years employment, Life in the UK Test.





# KEYPOINTS

- ▶ Anyone can apply providing they know someone they trust in UK.
- ▶ No academic requirements or work experience required (1-2 years work recommended).
- ▶ Quick visa process - around 3 months total.
- ▶ 5 year visa from the start so no further extension fees or risk.
- ▶ No performance required by UK company before or during length of visa (unlike all business visas).
- ▶ Can bring partner and children U18.
- ▶ Partner can work, Children free school.
- ▶ PR after 5 years + Passport 1 year later.



# REQUIREMENTS

- ▶ UK Director (Authorising Officer) & UK Company Registration.
- ▶ A UK director or Employee is required in the in the company in order to facilitate the sponsorship (Migrant cannot apply without person).
- ▶ Cannot be a family relative.
- ▶ Needs to live full time in the UK.
- ▶ No salary required if Director.
- ▶ Should be British/PR holder or on the following visas.
  - Overseas Rep
  - Entrepreneur
  - Exceptional Talent
  - Start up/Innovator



# PROCESS

- ▶ Step 1. Consultation, Program selection & sign up (Passport copy of all family members, utility bill of Principal applicant, Assessment Form)
- ▶ Step 2. Due Diligence & Technical Assessment (World Check / Interpol Check / Background Check Review of the profile by the lawyer)
- ▶ Step 3. Due Diligence & Technical Assessment report and Issuance of document checklist.
- ▶ Step 4. UK Director & UK Company Registration Government third party Company Registration Establishment
- ▶ Step 5. Establishing a UK Company - UK based Director, UK Bank Account, Employers Liability Insurance and Payroll Registration
- ▶ Step 6. Apply for a Skilled Worker sponsorship licence.
- ▶ Step 7. Apply for a Certificate of Sponsorship
- ▶ Step 8. Apply for Skilled Worker Visa, Government fee- £1235 pp & Health Surcharge 3120 PP.
- ▶ Step 9. Grant of 5 Years Skilled Worker Visa
- ▶ Step 10. PR
- ▶ Step 11. Nationality (if desired)
